## **Rutland Country Club~2018 Membership Classification**

### **Premium**

This is a Single membership with additional privileges. This would include 14-day Advance tee times, preferences in the weekend lottery tee times, a 10% discount on all guest fees and café purchases. It would also include cart rental for **yourself**, bag storage and 6 guest greens fees along with \$300 of pre-paid café credit. This membership is responsible for all capital assessments and any special assessments. Reciprocals when available.

### **Single**

This membership is defined as a person who shall have attained the age of 35 as of January 1<sup>st</sup> of the current golf season.

Single members will be responsible for full assessment charges, full café minimum, and must purchase a share of Stock. This membership will have no restriction of play. You will have top priority for all tournament entries after two years of membership.

### **Couples/Spousal**

A spousal membership will consist of 2 people, both being billed the same with unrestricted rounds. Full charging privileges, 2x café minimum and 2x full assessments (capital and/or special). One of the couples must be a stock holder.

### **Family Membership**

A family may consist of 2 people, and any children living at home up to the age of 18. Full charging privileges, 2x café minimum and 2x of the assessments (capital and/or special)

### **Super Senior**

To be eligible for this membership a person shall have attained the age of 80 during the current calendar year and have been a member of RCC for 5 years.

### **Young Professionals**

To be eligible for this membership a person must be between the ages of 19-34 as of January 1<sup>st</sup> of the current golf season. This membership is responsible for the assessment charges as well as the ½ monthly café minimum. This membership will be eligible for tournaments on a space available basis with priority given to the Senior Members.

Upon reaching the age of 35, a Young Professional will be upgraded to Single Membership and will be responsible for all costs.

**College Student**

To be eligible for this membership a person must be between the ages of 17-24 as of January 1<sup>st</sup> of the current golf season. Proof of college status required with a minimum of 12 credit hours per semester needed.

**Junior:**

To be eligible for this membership a person must be between the ages of 13-18 as of January 1<sup>st</sup> of the current golf season. Playing time is restricted to playing before ten and after two on weekdays, and after two-thirty on the weekends, unless accompanied by a Single member or with permission of the Pro Shop. A younger child may join if they have been assessed by the golf professional and has been deemed to have the ability.

**Derivative Junior:**

Any person who is under the age of 13 as of January 1<sup>st</sup> of current golf season and is the son or daughter of a current Senior member in good standing. They are not charged as they fall under their parent's membership. They are restricted to playing **only** with a single member.

**Social Membership**

This has full charging privileges. You will receive 3 guest greens fees, a \$250 prepaid café credit and reduced fees for use of the banquet room.

**Corporate Membership**

**\$5,000.00**
